## Villa Bellezza Winery & Township 23 Distillery Tours

Join the Golden Rewards Club for a day of local food, wine, and spirits as we tour close to home in Pepin and Nelson. Our first destination of the day is Villa Bellezza. Located in Pepin, Wisconsin, Villa Bellezza is an old world winery and vineyard designed in the style of an authentic Italian village. Brought to life by the husband and wife duo of Derick and Julianne Dahlen, the villa was inspired by their past visits to Italy. Here, we'll take a guided tour of their winery and get a firsthand look at the wine making process. Following our tour, we'll indulge in some wine tasting.

For our lunch, we'll travel a short distance down the river to J & J Barbecue in Nelson, Wisconsin where we'll enjoy a delicious buffet style lunch with pulled pork sandwiches, mac and cheese, and assorted vegetables.

Our second and final tour of the day will take place just outside Nelson, where we'll visit Township Twenty-Three Distillery. Founded in 2022 by Zach Hetrick, this local distillery uses grains from his family's own local crops to make spirits like vodka and gin. Staff at Township Twenty-Three will walk us through the distilling process as we tour their facility and in-house cocktail bar.

Bus pickup locations for this day trip are tentatively planned for Arcadia, Blair, Durand, Fountain City, and Mondovi. ## Quick Tips: Payable Upon Death Beneficiaries

In the event that all owners of an account pass away, the individual(s) listed as POD beneficiaries become the new owner(s) of that account. Having this form completed and signed ensures that if anything happens, your funds will go to the individuals you have selected. Signing the form is simple and can give you peace of mind. It's vital that you have designated beneficiaries for all of your accounts and that they remain up-to-date. Should you ever need to change beneficiaries on any of your accounts in the future, simply contact one of our employees at any of our eight locations. They can assist you with completing an updated POD form. Once an updated form is completed and signed, it will supersede any older version. Ask our employees about POD's during your next call or visit to us.
